### Data Protection: Privacy Notice for Contractors

#### 1 Why do we have this Notice?

The Museum is a **data controller** and is responsible for processing personal information about you. We are committed to complying with data protection law and protecting the privacy and security of your personal information. This Notice describes how and why we collect and use personal information about you during and after your working relationship with us and you should read this carefully to understand how we handle your personal information.

This Notice, which applies to current and former contractors, does not form part of any contract we have with you and the Museum reserves the right to change its terms at any time.

#### 2 What information might we hold about you?

Personal data, or personal information, means any information about an individual from which that person can be identified. We may collect, store, and use some or all of the following categories of personal information about you:

- Personal contact details such as name, title, addresses, telephone numbers, and business email addresses.
- Bank account details.
- Payment details and history.
- Contract award/start date.
- Location of workplace.
- Procurement information (references and other information included in a CV or tender document as part of the application process).
- Performance information.
- CCTV footage.
- Photographs.

#### 3 How is this information collected?

We collect personal information about you through the application and procurement process, either directly from you or sometimes from third parties including former clients, Companies House and credit reference agency Experian.

We will also collect additional personal information in the course of work-related activities throughout the period of you working for us.

## **4 How do we use this information?**

### **4.1 Our legal bases for using your personal information**

We need the categories of information in the list above (at paragraph 2) to allow us to:

- perform our contract with you; and
- to enable us to comply with legal obligations; and
- In some cases, we may use your personal information to pursue legitimate interests of our own or third parties.

We may also use your personal information in the following situations, which are likely to be rare:

- Where we need to protect your interests (or someone else's interests).
- Where it is needed in the public interest or for official purposes.

### **4.2 How we may use your personal information**

The types of situations in which we may process your personal information are listed below:

- Making a decision about your recruitment or appointment.
- Determining the terms on which you work for us.
- Paying you.
- Administering the agreement we have entered into with you.
- Business management and planning, including accounting and auditing.
- Conducting performance reviews, managing performance and determining performance requirements.
- Assessing qualifications for a particular job or task.
- Making decisions about your continued engagement.
- Making arrangements for the termination of our working relationship.
- Dealing with legal disputes involving you, or other employees, workers and contractors, including accidents at work.
- Complying with health and safety obligations.
- To prevent fraud.
- To ensure network and information security, including preventing unauthorised access to our computer and electronic communications systems and preventing malicious software distribution.

Some of the above grounds for processing will overlap and there may be several grounds which justify our use of your personal information.

## 5 Consent

We do not need your consent to process where we have another legal basis to do so as set out above. However, if we do need to seek your consent to processing, we will provide you with full details of the information that we would like and the reason we need it, so that you can carefully consider whether you wish to consent.

You should be aware that it is not a condition of your agreement with us that you agree to any request for consent from us and, where you have given consent, this can be withdrawn at any time by contacting the designated staff member or Governance Manager [governance@NMRN.org.uk](mailto:governance@NMRN.org.uk)

## 6 Automated decision making

We do not envisage that any decisions will be taken about you using automated means, however we will notify you in writing if this position changes.

## 7 Data Sharing

### 7.1 Why might you share my personal information with third parties?

We may have to share your data with third parties, (including third-party service providers and other entities in the group) where required by law, where it is necessary to administer the working relationship with you or where we have another legitimate interest in doing so.

If we do share data, we require third parties to take appropriate security measures and only process your data for specified purposes.

### 7.2 Which third-party service providers process my personal information?

“Third parties” includes third-party service providers (including contractors and designated agents) and other entities within our group. The following activities are carried out by third-party service providers: IT services, Finance services.

## 8 Data Security

We have put in place appropriate security measures to prevent your personal information from being accidentally lost, used or accessed in an unauthorised way, altered or disclosed. We also have procedures to deal with any suspected data security breach and will notify you and any applicable regulator of a suspected breach where we are legally required to do so.

## 9 Data Retention

We will only retain your personal information for as long as necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, accounting, or reporting requirements. Details of retention periods for different aspects of your personal information are available in our Document Retention Guidelines which is located in the staff room.

To determine the appropriate retention period for personal data, we consider the amount, nature, and sensitivity of the personal data, the potential risk of harm from unauthorised use or disclosure of your personal data, the purposes for which we process your personal data and whether we can achieve those purposes through other means, and the applicable legal requirements.

## 10 Rights of access, correction, erasure, and restriction

### 10.1 Your duty to inform us of changes

It is important that the personal information we hold about you is accurate and current. Please keep us informed if your personal information changes during your working relationship with us.

### 10.2 Your rights in connection with personal information

Under certain circumstances, by law you have the right to:

- **Request access** to your personal information (commonly known as a “data subject access request”). This enables you to receive a copy of the personal information we hold about you and to check that we are lawfully processing it.
- **Request correction** of the personal information that we hold about you. This enables you to have any incomplete or inaccurate information we hold about you corrected.
- **Request erasure** of your personal information. This enables you to ask us to delete or remove personal information where there is no good reason for us continuing to process it.
- **Object to processing** of your personal information where we are relying on a legitimate interest (or those of a third party) and there is something about your particular situation which makes you want to object to processing on this ground.
- **Request the restriction of processing** of your personal information. This enables you to ask us to suspend the processing of personal information about you, for example if you want us to establish its accuracy or the reason for processing it.
- **Request the transfer** of your personal information to another party.

### 10.3 No fee usually required

You will not have to pay a fee to access your personal information (or to exercise any of the other rights). However, we may charge a reasonable fee if your request for access is clearly unfounded or excessive. Alternatively, we may refuse to comply with the request in such circumstances.

### 10.4 What we may need from you

We may need to request specific information from you to help us confirm your identity and ensure your right to access the information (or to exercise any of your other rights). This is another appropriate security measure to ensure that personal information is not disclosed to any person who has no right to receive it.

We reserve the right to update this Privacy Notice at any time, and we will provide you with a new privacy notice when we make any substantial updates. We may also notify you in other ways from time to time about the processing of your personal information.
